

Deposits are Non Refundable

Cancellations with less than 14 days notice will be billed the total contract amount.

By signing this contract and entering your credit card information in the appropriate fields you are authorizing Florida Naples Limos To charge the credit card for any of the following charges; deposit, cancellation fee, damages to the vehicles, and all services rendered. We will calculate the exact amount of hours and charges when the trip is completed. We will then deduct your deposit amount leaving the actual balance due.

Limousine Rules and Regulations:

1. No alcohol consumed by anyone less than 21 years of age. Violation may result in early termination, no refunds.
2. No Smoking inside limousine, \$200.00 charges per incident. No exceptions.
3. \$250 clean-up fee for vomit in the limousine.
4. \$20.00 per broken or missing glasses.
5. \$100.00 clean up fee for excessive matter in limousine.
6. All unruly persons will be dropped off at the sole discretion of the driver (no refund given)
7. We will not be responsible for any lost, damaged, or stolen property. Please inspect vehicle soon after service ends.
8. No illegal drug use of any kind.
9. Overtime will be billed in one hour increments. (10 minutes after each hour no exceptions)
10. Cancellations must be made in writing by certified mail within 14 days of your scheduled event to avoid being billed the full contract.
11. Customer agrees that overtime will be billed at the contracted rate and agrees to pay any overtime charges.
12. Customer agrees that replacement Limousine or color may be substituted if contracted Limousine becomes unavailable for any reason. In case we do not have the replacement vehicle, Florida Naples Limos will farm out the service to a reputable company.
13. All entertainment including CDs, DVDs, Ipod, PS2 games, are to be provided by the client. In case any of the electronics in the vehicle are not functional, for example the PS2 or IPOD connector, we will not make any discount on the hourly. All electronics are provided at no extra cost, so the functionality is not calculated on the hourly of the vehicle
14. Emergency Exit or Sun Roof is to remain closed at all times. If the Sun Roof flies off due to a passenger opening it, a charge of \$700.00 will be billed on the credit card below, no exception.
15. No videos or photos recorded during the use of the limos will be used for public viewing without the written Consent of Florida Naples Limos
16. 25% Gratuity is automatically added to the price, along with any SPC charges (15%).
17. In the event that limo is down for 59 minutes or less during service do to a flat tire or belt failure, you will receive an additional 1 hour of service free plus the one hour the limo was down for, or full credit for the one hour only.
- 18 All jobs will be charged a non refundable \$250 deposit per limo booked
- 19 Weddings only; At times we will take picture and post them on either FB or our Website, if you disagree, please initial here _____
- 20 On classic vehicles only; in the event that temperatures outside are above 90 degrees, we do not guarantee the AC temperature inside the vehicle to operate as cold. Classics vehicle were not built to hold cold air inside, so no matter how efficient or well maintained the AC is, the temperature inside will never reach modern cars conditions.
21. We do not guarantee color of limousine, we take requests only.
22. Excessive amount of driving will incur additional charges. Any vehicles booked 45 miles from the home office will incur a drive time of 1 hour plus any additional excessive driving of 20 miles per hour. Any miles over the minimum will incur and Additional \$3.00 per mile over the hourly quoted.
23. On all proms and Homecoming, we will not allow anyone to use the vehicle while the dance or function is taken place unless prior arrangements are made with the office. Please keep in mind that additional charges will apply.
- 24 The start time and end time is for internal use only for drivers and office records.
- 25 Use of Fire Extinguisher without proper reason other than smoke or fire or theft will incur a \$200 charge and we will also charge for the cost of clean up not to exceed \$1500.00 plus criminal charges in case of bodily harm or injury to anyone including the driver.

In the event that I am signing this release on behalf of any minors, I represent that I have full authority to do so, realizing its biding effect on them as well as myself.
